Course Description

The course will cover general cloud computing concepts as well as general cloud computing models and services such as Public, Private and Hybrid cloud, and infrastructure as a service (laaS), platform as a service (PaaS), and software as a service (SaaS). It will also cover some core Azure services and solutions, and key Azure pillar services concerning security, privacy, compliance, and trust. Finally, it will cover pricing and support services available with Azure.

Course Schedule

This course is made up of a collection of modules. The modules open up at 12 AM on Monday and close at 11:59 PM on Sunday. The modules will be released one week at a time, unless stated otherwise. Each module may consist of a combination of the following activities:

Learning Content

The learning content for the course will consist of slides, videos and Azure documentation. This is an important element to be successful in this class. Weekly assignments such as labs and quizzes are dependent on understanding the learning content.

Assignments

Assignments like labs will help you get hands on practice with Azure. Make sure you go through the content before attempting the lab, or you will be lost. Between learning content and Azure documentation, you should be able to get through the labs easily.

Quizzes

Some of the modules will consist of quizzes that will act as a knowledge check. The learning content for the module should prepare you for the quiz. Due dates for the quiz will be clearly stated next to each quiz in Canvas.

Discussion Board

Your participation grade for the class will be dependent on occasional discussion board activities. You will be asked to post about a specific topic or scenario and might be asked to review or comment on your classmates posts as well.

Exams

There will be 2 exams in this course – a mid-term and a final.

UC Policies

Attendance: Students at the University of Cincinnati are expected to attend classes in order to meet the learning objectives for the course.
